# NATALES GAMBLING CASINO PERMIT CONTEXT

In 1990, the law that allowed the Natales municipality to grant a municipal concession for a gambling casino was approved.


In 2005, Law N°19.995 was approved, establishing the general basis for the gambling casino industry in Chile. A term of 10 years was established for the transition to the general regime of the old municipal gambling casinos.

In 2015, Law N°20.856 established that Natales municipality would continue to host a gambling casino for three periods of 15 years and the permit granting process was modified.

Two granting processes (tenders) have been carried out, without any bidders.

For the 2023 process, the installation and operation conditions of the gambling casino were made more flexible.

The operating permit is valid for 15 years, renewable in a new bidding process.



# **INVEST**MENT PROJECT CHARACTERISTICS

#### Minimum requirements:

- Investment in fitting out a gambling casino with a bar and a restaurant.
- Minimum Project investment of UF 70.220 (US\$ 3.160.000 approx.)
- UF 3.000 investment (US\$135.000 approx.) in improvement works with a tourist impact in the municipality.
- Minimum annual economic offer of UF 5.000 (US\$225.000 approx.) for Natales municipality.


- 4 or 5 stars hotel investment inside of the integrated project.
  - Every authorized gambling casino project since 2006 had considered a hotel.
  - In many cases, it becomes the main establishment in the city.

Event center and entertainment venues investment.

# **OPERATION PERMIT TRACK**

#### Instalation

- Up to two years according to the operation plan. Extendable for 12 months for gambling casino and 18 months for complementary works.
- During this period, sectoral permits must be obtained and the committed works must be carried out.
- SCJ will monitor the progress status of the Project.

#### Certification



Being in a position to start the operation og the gambling casino, it must be notified to the SCJ.

- SCJ Will review that all the legal and regulatory obligations are met.
- SCJ will deliver the certificate that enables the operation of the gambling casino.

#### Operation

- 15 years from the start of operation of
- the gambling casino.

Annual payment of the committed economic offer.

Permanent inspection from SCJ.

Tax payment:

- VAT, 19% of gambling incomes.
- Specific tax, 20% of the gambling net income discounted VAT (50% to the municipality and 50% to the regional government).
- Tickets, UTM 0,07 per visit.



#### **POSSIBILITIES ALL YEAR ROUND**



- Winter season was launched for the first time in Puerto Natales in 2023.
- Hotels that typically operated from September to April will now operate continuously.
- $\checkmark$
- First year with continuous operation of Santiago Puerto Natales flights. Flights 3 to 4 days a week between May and September.
- During the high season, three Airlines operate the Santiago Puerto Natales route.
- Extension of the operating hours of the "Paso Dorotea" border crossing.
- Business tourism growth:
  - Attractive destination for international congresses and seminars. For example, the 2022 Motivation Luxory Summit international fair took place in Puerto Natales.
  - Activities related to salmon farming.
- Gastronomic hub of Magallanes Region.
- Origin of international tourists: 47,3% come from Europe, 31,4% from the United States or Canada, 8,4% from Latin America, 6,3% from Asia, 4,9% from Australia and 1,8% from elsewhere.




# **HOTEL OFFER**

- Rooms offer in the Natales municipality and Torres del Paine was a total of 2.148.
- ✓ 42% of the offer corresponds to hotel rooms.

- Within the activities of production of goods, salmon farming is a rapidly growing activity in Puerto Natales. In 2022, the first trade association was established, promoting the installation of local suppliers.
- The real state industry has presented a strong demand boom, with investment projects completely sold.

- The purchasing power of the inhabitants of the Natales municipality is high compared to the rest of the country, having an average salary in the municipality of over \$1.000.000.
- Important demographic growth.
- - \$3.000 million public investment in the waterfront.
- \$70.000 million of projected public investment in the airport. Converting to international operation and a second runway for loading salmon.
